**Structure:** pinewood, multilayer and plywood covered with polyurethane foam. Back cushions lean on a metal mechanism\*.

Spring system: elastic webbing

**Seat Padding:** in ecological polyurethane foam covered with 100% polyester padding.

**Back Padding:** in ecological polyurethane foam covered with 100% polyester padding.

**Arm Interior:** in ecological polyurethane foam covered with 100% polyester padding.

Removability: not available

**Sewing:** leather coverings feasible with contrast stitching in the colors available; cuts and sewings vary on microfiber (or fabric) coverings.

**Mechanisms:** \*the model is equipped with a metal mechanism that can be operated manually to move the back cushions backwards and forwards so, to get different seat comforts. With backrests positioned backwards the seat depth lengthens by 44 cm, the total depth of the model increases by 27 cm and the depth of version D10 increases by 15 cm

**Standard feet:** PM2257 on armrest sides, PM2258 on rectangular ottoman, RHF/LHF chaise long, terminal and armless sides, both in shiny metal, h. 17 cm, available in the following color options: satinized, titanium, graubraun, antique bronze. Some versions may be equipped with hidden feet with a supporting structural function.
